WHAT DOES BLBB ADVISORS DO WITH YOUR PERSONAL INFORMATION?

WHY?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

WHAT?

The types of personal information we collect and share depend on the product or service you have with us. This personal information can include:

- Name, address, or other non-public personal information
- Social Security Number and Income
- Account Balances and Transaction History
- Assets and Employment History

When you are *no longer* our customer, we continue to share your information as described in this notice.

HOW?

All financial companies need to share customer information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information, the reasons BLBB Advisors chooses to share, and whether you can limit this sharing.

Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.

Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.
